

## 2022 CFLE Special Recognition Award Nomination Form

The intention of the National Council on Family Relation (NCFR) **Certified Family Life Educator (CFLE) Special Recognition Award** is to recognize an individual(s) who has demonstrated exceptional effort in promoting, supporting, or improving the CFLE credential or program. These efforts can be demonstrated through committee involvement, development of related publications or materials, advocacy, or marketing and outreach efforts. Nominees can be individuals (academic or practitioner) or teams of CFLE individuals.

### **Nominee Criteria —**

- Current status as a Certified Family Life Educator (up to date with all CFLE fees and requirements)
- Current member of the National Council on Family Relations (preferred but not required)
- have held active CFLE status (provisional, full, retired, or emeritus) for at least five *continuous* years; and
- have demonstrated a contribution to the advancement of the CFLE credential.

Please provide a statement (maximum 500 words) that demonstrates your/their contribution to the advancement of the CFLE credential. Identify specific CFLE-related activities or events, including committee involvement, advocacy, marketing and outreach, and/or development of CFLE-related publications or resources that promote the CFLE credential. Please include information as to how the CFLE credential benefited from the nominee's effort. Please also provide information describing significant outcomes and impacts that have occurred because of their efforts.
- Abbreviated **vita or resume** (maximum three pages) highlighting contributions to the CFLE credential
- **Letter of support** - Applicants must provide a letter of support that describes the nominee's contribution to advancing the CFLE credential.
